## ATHABASCA DUNES ECOLOGICAL RESERVE

### FIRSTLY:

All those parcels or tracts of land, situate, lying and being in the one hundred and fifth (105) township, in the sixth (6) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections thirty-four (34) and thirty-six (36), the north west quarter of section twenty-seven (27), the north east quarter of section twenty-eight (28), the east half of section thirty-three (33), the north half and the south east quarter of section thirty-five (35), all those portions of the north west quarter of section twenty-six (26) and the north east quarter of the said section twenty-seven (27), which lie to the north and west of the westerly shoreline of an unnamed lake, and all that portion of the south west quarter of the said section thirty five (35) of the said township, not covered by any of the waters of the said unnamed lake, containing one thousand one hundred six and forty-five thousandths (1,106.045) hectares (2,733.00 acres), more or less.

### SECONDLY:

All those parcels or tracts of land, situate, lying and being in the one hundred and sixth (106) township, in the sixth (6) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections one (1), two (2), three (3), ten (10), eleven (11), twelve (12), fourteen (14) and fifteen (15), the east halves of sections four (4), nine (9), and sixteen (16), and all those portions of section thirteen (13) of the said township, which lie generally to the west of the left bank of the Maybelle River, containing two thousand six hundred fifty-four and eight hundred thirty-two thousandths (2,654.832) hectares (6,560.00 acres), more or less.

### THIRDLY:

All that parcel or tract of land, situate, lying and being in the one hundred and sixth (106) township, in the fifth (5) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

All those portions of the north west quarter of legal subdivision thirteen (13) of section seven (7), and the south west quarter of section eighteen (18) of the said township, which lie generally to the west of the left bank of the Maybelle River, containing eight and nine hundred three thousandths (8.903) hectares (22.00 acres), more or less.

The lands herein described contain three thousand seven hundred sixty-nine and seven hundred eighty-one thousandths (3,769.781) hectares (9,315.00 acres), more or less.
