PEACE RIVER WILDLAND PROVINCIAL PARK

FIRSTLY:

All those parcels or tracts of land, situate, lying and being in the eightieth (80) township, in the twenty-third (23) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

The north half of section ten (10), section fifteen (15), the east half of the east half of section sixteen (16), the east half of section twenty-one (21), the west halves of sections twenty-two (22) and twenty-seven (27), sections twenty-eight (28) and thirty-three (33) and the west half of the west half of section thirty-four (34) of the said township.

SECONDLY:

All those parcels or tracts of land, situate, lying and being in the eightieth (80) township, in the twenty-fifth (25) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

The west half of section one (1), sections two (2), three (3) and four (4), the north halves of sections seven (7) and eight (8), the west half of section nine (9), the south west quarter of section twelve (12), the west half of section sixteen (16), the south half of section seventeen (17), the west half of section thirty-six (36) and all that portion of the north half of the said section seventeen (17) of the said township lying generally to the south and east of the right bank of the Peace River.

THIRDLY:

All those parcels or tracts of land, situate, lying and being in the eightieth (80) township, in the twenty-sixth (26) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

The north west quarter and legal subdivisions five (5) and six (6) of section one (1), the north half and south west quarter and legal subdivisions seven (7) and eight (8) of section two (2), the south half of section three (3), the fractional south east quarter of section four (4), the south east quarter of section eleven (11), section twelve (12) and all those portions of the north half of the said section three (3), the fractional north east quarter of the said section four (4), the south east quarter of section ten (10), the north half and south west quarter of the said section eleven (11) and the south half of section thirteen (13) of the said township lying generally to the south and east of the said right bank of the Peace River.

FOURTHLY:

All those parcels or tracts of land, situate, lying and being in the eighty-first (81) township, in the twenty-third (23) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

The north half and south west quarter of section three (3), the south half and north east quarter of section four (4), the east half of section nine (9), section ten (10), the north half and south west quarter of section fourteen (14), section fifteen (15), the south east quarter of section sixteen (16), sections twenty-two (22) and twenty-three (23), the north half and south west quarter of section twenty-five (25), section twenty-six (26), the east half of section twenty-seven (27), the north west quarter of section thirty (30), section thirty-one (31), the south west quarter of section thirty-four (34), the east half of section thirty-five (35) and all that portion of the west half of section thirty-six (36) of the said township lying generally to the west of the left bank of the Smoky River.

FIFTHLY:

All those parcels or tracts of land, situate, lying and being in the eighty-first (81) township, in the twenty-fourth (24) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

The south half and north east quarter of section seven (7), section eight (8), the north halves of sections nine (9) and ten (10), section eleven (11), the west halves of sections twelve (12) and thirteen (13), section fourteen (14), the south halves of sections fifteen (15), sixteen (16) and seventeen (17), the east half of section twenty-three (23), the west half

of section twenty-four (24), the north half and south west quarter of section twenty-five (25), the south east quarters of sections twenty-six (26) and thirty-six (36) and all those portions of the north west quarter of the said section seven (7), the north halves of the said sections fifteen (15), sixteen (16) and seventeen (17), the south half and north east quarter of section eighteen (18), the south east quarter of section twenty-two (22), the west half of the said section twenty-three (23), the north half and south west quarter of the said section twenty-six (26), the south east quarter of section thirty-five (35) and the north half and south west quarter of the said section thirty-six (36) of the said township lying generally to the south and east of the said right bank of the Peace River.

SIXTHLY:

All those parcels or tracts of land, situate, lying and being in the eighty-first (81) township, in the twenty-fifth (25) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

The south east quarter of section one (1) and all those portions of the north half and south west quarter of the said section one (1), the south half of section two (2) and the east half of section twelve (12) of the said township lying generally to the south and east of the said right bank of the Peace River.

SEVENTHLY:

All those parcels or tracts of land, situate, lying and being in the eighty-second (82) township, in the twenty-second (22) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

The north half and south west quarter of section five (5), the south east quarter of section six (6), the south half and north east quarter of section eight (8), the north half and south west quarter of section sixteen (16), the north half and south west quarter of section eighteen (18), the south half and north east quarter of section twenty (20), section twenty-one (21), the north west quarter of section twenty-two (22), the west half of section twenty-seven (27), sections twenty-eight (28) and twenty-nine (29), the south half of section thirty-two (32), sections thirty-three (33) and thirty-four (34), the north west quarter of section thirty-five (35), all those portions of the north half and south west quarter of section seven (7) lying generally to the north and west of the left bank of the said Smoky River, all those portions of the north half and south east quarter and legal subdivision six (6) of section seventeen (17) lying on both sides of the said Smoky River, all that portion of the south east quarter of the said section eighteen (18) lying generally to the north and west of the left bank of the said Smoky River, all those portions of the south half and north west quarter of section nineteen (19) lying generally to the south and west of the southwesterly limit of a surveyed roadway, as shown upon a plan of survey of record in the Land Titles Office at Edmonton for the North Alberta Land Registration District as No. 842 1773 and all that portion of the north west quarter of the said section thirty-two (32) of the said township lying generally to the south and east of the said right bank of the Peace River.

SAVING AND EXCEPTING:

- (1) Eight hundred two thousandths (0.802) of a hectare (1.98 acres), more or less, required for a surveyed roadway, as shown upon the said plan No. 842 1773.
- (2) Four and one hundred twenty-eight thousandths (4.128) hectares (10.20 acres), more or less, required for a surveyed roadway, as shown upon a plan of survey of record in the said Land titles Office as No. 882 2191.
- (3) Eleven and sixty-two thousandths (11.062) hectares (27.33 acres), more or less, required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 852 0215.

EIGHTHLY:

All those parcels or tracts of land, situate, lying and being in the eighty-second (82) township, in the twenty-third (23) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

The east half of section two (2), the south half and north east quarter and legal subdivisions eleven (11), twelve (12) and fourteen (14) of section five (5), the south east quarter of section six (6), the south half of legal subdivision two (2) of section eight (8), the south half of section ten (10), the north west quarter of section eleven (11), sections twelve (12)

and thirteen (13), the south east quarter of section fourteen (14), the south half and north east quarter of section twenty-four (24), all those portions of the north half and south west quarter of section one (1) lying generally to the north and west of the said left bank of the Peace River, all those portions of the south west quarter and legal subdivisions nine (9), ten (10) and eleven (11) of the said section six (6), the north half of the said section ten (10), the north half and south west quarter of the said section fourteen (14) and the south east quarters of sections fifteen (15) and twenty-three (23) lying generally to the south and east of the said right bank of the Peace River, all that portion of the north east quarter of section four (4) lying generally to the east of the easterly limit of a surveyed roadway, as shown upon the said plan No. 802 0439, all those portions of the south half of the said section four (4) lying generally to the east of the easterly limits of two (2) surveyed roadways, as shown upon plans of survey of record in the said Land Titles Office as Nos. 942 0029 and 802 0439, all that portion of legal subdivision one (1) of the said section eight (8) lying generally to the south of the southerly limit of a surveyed roadway, as shown upon the said plan No. 802 0439 and all those portions of the south half and north east quarter of section nine (9) of the said township lying generally to the south of the southerly limit of a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 842 1475.

SAVING AND EXCEPTING:

- (1) Thirteen and two hundred seventy thousandths (13.270) hectares (32.79 acres), more or less, required for a surveyed roadway, as shown upon the said plan No. 802 0439.
- (2) Eighteen and eight hundred eighty-seven thousandths (18.887) hectares (46.67 acres), more or less, required for a surveyed roadway, as shown upon the said plan No. 842 1475.

NINTHLY:

All that parcel or tract of land, situate, lying and being in the eighty-second (82) township, in the twenty-fourth (24) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

All that portion of the south east quarter of section one (1) of the said township lying generally to the south and east of the said right bank of the Peace River.

TENTHLY:

All those parcels or tracts of land, situate, lying and being in the eighty-third (83) township, in the twenty-first (21) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

The north west quarter of section six (6), the east half of section seven (7) and all those portions of the west half of the said section seven (7) and the south half and north east quarter of section eighteen (18) of the said township lying generally to the south and east of the said right bank of the Peace River.

SAVING AND EXCEPTING:

Ten and eight thousandths (10.008) hectares (24.73 acres), more or less, required for a surveyed railway right-of-way, as shown upon a plan of survey of record in the said Land Titles Office as No. 3284 B.U.

ELEVENTHLY:

All those parcels or tracts of land, situate, lying and being in the eighty-third (83) township, in the twenty-second (22) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

The south halves of sections one (1) and two (2), all that portion of the north half of the said section one (1) lying generally to the east of the said right bank of the Smoky River, all those portions of the north half of the said section two (2), the south half and north east quarter of section three (3), the south east quarters of sections four (4) and eleven (11) and the south west quarter of section twelve (12) lying generally to the south and east of the said right bank of the Peace River and all that portion of the south east quarter of the said section twelve (12) of the said township lying generally to the east of the said right bank of the Smoky River and to the south of the said right bank of the Peace River.

TWELFTHLY:

All those parcels or tracts of land, situate, lying and being in the seventy-ninth (79) township, in the first (1) range, west of the sixth (6) meridian, in the Province of Alberta, Canada, and being composed of:

The north west quarter of section sixteen (16), sections nineteen (19), twenty (20) and twenty-one (21), the south west quarter of section twenty-two (22), legal subdivisions twelve (12) and thirteen (13) of section twenty-nine (29), sections thirty (30) and thirty-one (31) and the west half of the west half of section thirty-two (32) of the said township.

THIRTEENTHLY:

All those parcels or tracts of land, situate, lying and being in the seventy-ninth (79) township, in the second (2) range, west of the sixth (6) meridian, in the Province of Alberta, Canada, and being composed of:

The north half of section seven (7), the north half and the north half of the south half of section eight (8), the north west quarter of section nine (9), the north half of section thirteen (13), the north east quarter and legal subdivisions four (4), five (5), six (6), eleven (11) and twelve (12) of section fourteen (14), legal subdivisions five (5) to twelve (12) inclusive of section fifteen (15), the west half and legal subdivisions two (2), seven (7), eight (8), nine (9) and ten (10) of section sixteen (16), the south half and legal subdivisions nine (9), ten (10), eleven (11), twelve (12) and sixteen (16) of section seventeen (17), the south half and the south half of the north half of section eighteen (18), legal subdivision one (1) of section twenty (20), legal subdivisions one (1) to four (4) inclusive and the south halves of legal subdivisions five (5) to eight (8) inclusive of section twenty-one (21), the south half of section twenty-two (22), the south half, legal subdivisions nine (9) and ten (10) and the south halves of legal subdivisions fifteen (15) and sixteen (16) of section twenty-three (23), the south half and north east quarter, legal subdivisions eleven (11) and twelve (12) and the south halves of legal subdivisions thirteen (13) and fourteen (14) of section twenty-four (24) and legal subdivisions one (1), two (2) and eight (8) of section twenty-five (25) of the said township.

FOURTEENTHLY:

All those parcels or tracts of land, situate, lying and being in the seventy-ninth (79) township, in the third (3) range, west of the sixth (6) meridian, in the Province of Alberta, Canada, and being composed of:

The north half of section two (2), the north east quarter and legal subdivisions eleven (11), twelve (12) and fourteen (14) of section three (3), legal subdivisions one (1) and two (2) and the south half of legal subdivision eight (8) of section ten (10), the south half and north east quarter and the south half of legal subdivision eleven (11) of section eleven (11), the north half and south west quarter and legal subdivisions two (2) and seven (7) of section (12), the south half and the south half of the north half of section thirteen (13) and the north halves of sections thirty-three (33), thirty-four (34) and thirty-five (35) of the said township.

SAVING AND EXCEPTING:

- (1) All those portions of the described lands required for DRS. 333.
- (2) Seven and five hundred twenty-three thousandths (7.523) hectares (18.59 acres), more or less, required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 902 0193.

FIFTEENTHLY:

All those parcels or tracts of land, situate, lying and being in the eightieth (80) township, in the first (1) range, west of the sixth (6) meridian, in the Province of Alberta, Canada, and being composed of:

The south east quarter and legal subdivisions five (5) and six (6) of section one (1), the north west quarter and legal subdivisions seven (7) and eight (8) of section two (2), the north halves of sections three (3) and four (4), the north half and legal subdivisions four (4) and five (5) of section five (5), the south half and north west quarter of section six (6)

and all those portions of the north half of the said section one (1), the north east quarters of the said sections two (2) and six (6) and the south halves of sections seven (7) to eleven (11) inclusive of the said township lying generally to the south of the said right bank of the Peace River.

SIXTEENTHLY:

All those parcels or tracts of land, situate, lying and being in the eightieth (80) township, in the second (2) range, west of the sixth (6) meridian, in the Province of Alberta, Canada, and being composed of:

The north halves of legal subdivisions thirteen (13) and fourteen (14) of section three (3), the north halves of legal subdivisions five (5) and six (6) and legal subdivision sixteen (16) of section four (4), the north halves of legal subdivisions five (5) to eight (8) inclusive of section five (5), the north east quarter and legal subdivisions eleven (11), thirteen (13) and fourteen (14) of section six (6), the south east quarter of section eleven (11) and all those portions of the north west quarter and legal subdivision fifteen (15) of the said section four (4), the north half of the said section five (5), section seven (7), the south west quarter of section eight (8), the south east quarter of section nine (9), the south half of section ten (10), the north half and south west quarter of the said section eleven (11) and the south half and north west quarter of section twelve (12) of the said township lying generally to the south of the said right bank of the Peace River.

SEVENTEENTHLY:

All those parcels or tracts of land, situate, lying and being in the eightieth (80) township, in the third (3) range, west of the sixth (6) meridian, in the Province of Alberta, Canada, and being composed of:

Legal subdivisions four (4), six (6), ten (10), fifteen (15) and sixteen (16) of section one (1) and all those portions of the north west quarter and legal subdivision five (5) of the said section one (1) and the south halves of sections two (2), three (3), four (4) and twelve (12) of the said township lying generally to the south of the said right bank of the Peace River.

SAVING AND EXCEPTING:

All those portions of the described lands required for DRS. 333.

The lands herein described contain twenty-four thousand five hundred sixty-three and one hundred eighty thousandths (24,563.180) hectares (60,694.79 acres), more or less.
